1. Welcome and Roll

3. County Storm Water Training  
The Coalition was presented with the date of February 4, 2014 as the date for the next Utah County Storm Water training. The same location was chosen for the training at the Utah County Health and Justice Building, 151 South University Ave. Provo Utah, Suite 1600. The time chosen to start the breakfast will be 7:00A.M., beginning the general welcome and introduction at 8:00A.M. Breakout sessions will be conducted after the general session to focus on various trainings to assist a targeted audience of contractors and industries in the Utah County area with subjects such as SWPP, MS4, Housekeeping, as well as coordinating storm water training for all city employees in Utah County. The length of each class will not exceed 2-3 hours. Completion of all classes should be no later than 10AM that morning. In the past, it was noted that classes no longer that 2-3 hours had greater interest by those attending them. Coalition members are to send all training topic ideas to Glen Tanner by email before November 15, 2013. The host training company will go out to bid the same as last year. In 2013, ACCENA won the bid with a total cost of \$5,500.00 for trainers, supplies and materials.

The time has come to once again approve the Storm Water Interlocal Agreement with all the Cities in Utah County. A copy of the agreement will be sent out to all Coalition members by email. The Coalition suggested that the Interlocal Agreement be drafted for a duration of ten (10) years before the agreement would need to be reviewed and approved.

Written with an allowance for a non-member City who wishes to become a member can do so at any time during that ten (10) years and allowing the Coalition to make any needed finance changes upon the City's acceptance. The adoption of the Interlocal Agreement will take place at the next Coalition meeting.

Bids will be gathered to do the next City Survey to calculate coalition fees. At this time, there is no need to increase fees to the Cities that are members of the Storm Water Coalition. Most Cities are staying with the same amount of schools seen this past year.

It is recommended that all Coalition members be present. Any suggestions for changes need to be emailed to Glen Tanner as soon as possible.

5. Utah State Storm Water updates  
There was no meeting scheduled in October for USWAC.
