4. USWAC update presented by Nestor Gallo

The main focus of the State will be audits for all storm water agencies. One of our storm water members, Spanish Fork City, was the winner of the storm water agency of the year 2015. Juan Garrido was the winner for Storm Water Inspector of the year. What a privilege it is to have two winners for this year come from our agency!

The State is updating their web site to make it more user friendly. There is a video on the site recommended for members to view called "Utah Lake Legacy".

A reminder was given to sign up for the Low Impact of Development training that is coming up. Make sure to click on "buy a ticket". There is no fee for the ticket. Rhonda will be one of the presenters speaking on the regulations for Low Impact of Development.

5. Discussion of the St. George City Audit – Nestor Gallo

Nestor presented a review of the DWQ Audit that was submitted to the City of St. George. This information can be used to assist the Coalition members to think about the things they need to implement in their agencies prior to their next audit. Each member is encouraged to contact Nestor. He has resources available to help them update their storm water procedures. A copy of the audit will be sent to each member for them to use as a guideline. It has been observed that a second audit can be tougher than the first. This can lead to higher fines and penalties. Utah County Storm Water Coalition does not want to have any members have fines imposed on them. He suggested that you get assistance from any one in the Coalition to help you if you do not understand how something is to be implemented. Flow charts, spread sheets, maps can be easily emailed to anyone. Document and track and record all the activities that you are doing for your storm water procedures. Develop written procedures for locating and listing priority areas. It was suggested to map them, color code them, etc. Make sure your ordinances match the State requirements. Be familiar with your procedures. You will be quizzed on them during an audit. Invite and train property owners, employees, and those that will be held responsible in your Cities for implementations of storm water procedures. It is a good idea to document those that you have invited to your trainings if they come or not.
